#### Call for nominations for the President's University-Wide Teaching Awards

The President's University-Wide Teaching Awards (UWTA) honour those individuals who, through innovation and commitment, have significantly enhanced the quality of learning for York students. Four awards are offered each year in the following categories:

- Full-time faculty with 10 or more years of teaching experience;
- Full-time faculty (tenured, tenure-stream, contractually limited appointments) with less than 10 years of experience;
- Contract and adjunct faculty;
- Teaching assistants.

The purpose of these awards is to provide significant recognition for excellence in teaching, to encourage its pursuit, to publicize such excellence when achieved across the University and in the wider community, and to promote informed discussion of teaching and its improvement. The awards demonstrate the value York University attaches to teaching.

Recipients of the awards, selected by the Senate Committee on Awards, receive \$3,000, have their names engraved on the University-Wide Teaching Awards plaques in Vari Hall and are recognized at convocation ceremonies. Nominations can be submitted by faculty, students or alumni.

### “A Conflict of Rights? On the Recent Controversy over Religious Accommodation at York”

**Presented by Stephen Newman**

What should be done when a male student requests to be excused from participation in a group assignment requiring him to interact with female students against his sincerely held religious belief that this would be improper? Is the student owed religious accommodation, or does his request exceed the bounds of reasonable accommodation? Are the student's beliefs necessarily anti-feminist?

Does his request violate the university's commitment to gender equality? If the course director were to grant the request, does he/she implicitly endorse the student's religious beliefs? Would granting the student's request inflict intolerable harm on women students in the class? Does the student's request confront us with a conflict of rights pitting religious freedom against equality?

### **18th Annual Conference of the International Research Society for Public Management (IRSPM)**

#### **Intersections: Governance, Democracy, Accountability**

The changing relationships among the public, private and nonprofit sectors are raising important issues for public management. Policy is increasingly 'mashed-up,' extending across multiple departments, relying on a diversity of agents for implementation and requiring new approaches to effective oversight. To varying degrees, both centralisation of executive powers and decentralisation of authorities are at play. Public management risks being hyper-politicised, just as citizens are demanding more meaningful engagement and utilising new channels to obtain it. These demands, in concert with financial constraints, have many worried about issues of democracy and accountability. At this crowded intersection, there are few easy answers, and the challenge for public management today is to formulate new ways to navigate these competing pressures.

IRSPM 2014 explores the implications for public management of the evolving intersections of governance, democracy and accountability.

## THE MACKENZIE KING SCHOLARSHIPS 2014

The following is information regarding the 2014 W.L. Mackenzie King Open and Travelling Scholarships.

The **Open Scholarship** is available to graduates of Canadian universities who pursue graduate study in any discipline, in Canada or elsewhere. One Open Scholarship is awarded each year. The value has recently been about \$9,000 but it is subject to change.

The **Travelling Scholarship** is available to graduates of Canadian universities who pursue graduate study in the United States or the United Kingdom in the areas of international relations or industrial relations. Recently four scholarships of \$11,000 each have been awarded annually, but the number and the amount are subject to change.

**HOW TO APPLY:** Applications must be made to the Faculty of Graduate Studies of your “home”

**university.** This is the *Canadian* university from which you most recently graduated or at which you are currently enrolled. You must be a graduate of a Canadian university when tenure of the scholarship begins. You may apply for both scholarships with a single application if the eligibility criteria are met for both.

**Completed** application packages, including all of the documents listed above, must be submitted to Sandra Yiu at the Faculty of Graduate Studies, 230 York Lanes. Please **do not** have reference letters and/or transcripts sent separately.

**The scholarship deadline is February 1, 2014.**

**Volunteers at Pan Am Games will get help with student loan payments**

Post-secondary students who lend a hand at the Toronto 2015 Pan Am/Parapan Am Games will be getting some help of their own when it comes to their student loan payments.

The province announced Tuesday that volunteering students won't have to make their pre-study financial payment in recognition of them not picking up paid work during the summer break that year.

Meanwhile, those graduating from full-time courses who help out will have the usual six-month grace period before they have to start paying back their loans doubled to a year.

In making the announcement, the Minister of Training, Colleges and Universities Brad Duguid said volunteering at the Games will help students make a lasting impact on their communities and build valuable skills for the future.

"(Students) shouldn't have to choose between pursuing the opportunity of a lifetime and investing in their future," Duguid said.

The \$1.9-million program is expected to help about 4,500 students volunteering with the Games.

A total of 20,000 volunteers will be involved with the sporting events, billed as the largest ever in the province. Their duties will range from collecting tickets to shuttling athletes across the city. Recruitment for volunteers begins in mid-April and those who are selected will be contacted in September.

Saad Rafi, the Games' new chief executive officer, said they are looking for people who are "creative problem solvers, outgoing and interested in the world and passionate of their community." "Our volunteers will be the face and the heart of the Games."
