# Toronto Star Article Written by SPPA Professor Thomas Klassen: Ontario pension plan good politics, but bad policy

The unprecedented proposal by the province of Ontario to create its own public pension plan to supplement the Canada Pension Plan is magnificent politics. The proposal plan is fraught with dangers and implications that extend beyond the election campaign.

Premier Kathleen Wynne is correct in concluding that having adequate retirement income is a worry for many people, especially for those of middle and low income. Canada's two public pensions — Old Age Security and the Canada Pension Plan — are modest. The age of eligibility for federal Old Age Security will gradually increase from the current 65 to 67 starting in 2023.

Employers in Canada are not required to establish their own pension plans, and most do not. Just over one-third of workers have employer pension plans, with most of these in stable and relatively well-paying jobs. Many employers are reducing the scope of their pensions or eliminating them altogether. Some are shifting from defined benefit schemes, which guarantee a specified payment upon retirement, to defined contribution schemes in which payments are a function of how well investments perform.

Even as a secure retirement becomes more precarious for Canadians, the proposal for a made-in-Ontario solution is mediocre policy because reforming the CPP would better

Strengthen retirement income. Even more alarming, a new pension plan will balkanize Canada and weaken the federation.

No province, other than Quebec, has its own public pension plan. Quebec's plan has almost identical rules as the CPP and its benefits are the same as the national plan. This means that regardless of province of residency, workers and employers are members of the same, or portable, pension schemes.

If Ontario creates its own plan to top up the CPP, other provinces will follow. There is no constitutional impediment to individual provinces establishing public pension schemes. Once this occurs, the CPP will fade in importance, as each province tweaks its supplementary plan to suit political and economic circumstances.

Workers and employers will start to consider pension schemes when deciding on whether, and where, to relocate. Complex new rules may be required for those who lived and worked in several provinces.

Behind Ontario's proposal is the <u>unwillingness of Prime</u> Minister Stephen Harper to reform the CPP. The threat of

an Ontario plan is a bargaining chip in the ongoing battle between Ottawa and many of the provinces, including Ontario, that want to see enhancements to the CPP.

The Ontario Liberals have promised to implement their plan to require contributions of 1.9 per cent each from employer and employee (3.8 per cent combined) on earnings up to \$90,000.

These contribution limits will be in addition to the 4.95 per cent currently required by the CPP from employer and employee on earnings up to \$52,500. Therefore the Ontario plan is a significant expansion of benefits that for some workers would nearly double what they would receive from the CPP alone.

If the Liberals are re-elected, they will have the mandate to set up their plan. Ottawa will be backed into a corner: having to consent to expand the CPP along the lines of Ontario's plan or watch the slow demise of the CPP.

The best public pension arrangements are stable, predictable and provide for adequate retirement income for those most at risk of poverty in old age. Rapid shifts or uncertainty in public pensions trigger anxiety among workers and employers, and doubts among families saving for retirement.

Public pensions should be a topic of debate in electoral campaigns, especially with the large baby boom generation approaching the age of retirement. However, politicians — those who propose expanding pensions and those who oppose strengthened pensions — need to better inform voters of the rationale and implications of their stance.

The CPP has been a cornerstone of retirement income for nearly 50 years. If the time has come for it to be supplemented by provincial schemes, federal and provincial politicians must explain to Canadians the consequences of doing so.

A University Professor is a long-serving, tenured faculty member who has made an extraordinary contribution to the University as a colleague, teacher and scholar, including significant long-term contribution to the development or growth of the University or its parts; significant participation in the collegium through mentorship, service and/or governance; sustained impact over time on the University's teaching mission; and recognition as a scholar.

During her time at York University, **Susan Dimock** has been an active member of the collegium and has participated in many aspects of University governance. She has been the chair of the University Senate, chair of Faculty Council, master of McLaughlin College, director of the York Centre for Practical Ethics, president of the York University Faculty Association, and a member of the hiring committees for both the President and the Provost of York.

Dimock's research interests span topics in ethical theory and practical ethics, including political and public sector ethics, political philosophy and the philosophy of law. She is currently researching criminal law and criminal justice within the framework of a broader political conception of a just society.

In addition to being an active researcher and author of numerous books and scholarly articles, Dimock

teaches both undergraduate and graduate courses in moral, political and legal philosophy. She is a winner of York's most prestigious teaching award—the President's University-Wide Teaching Award—and has developed a range of pedagogical materials for teaching philosophy. Her passion for and wide mastery of topics in value theory, her wit and her extraordinary presentation skills combine to make her a sought-after speaker. Dimock participates in a variety of scholarly workshops and conferences throughout the world.

### Pakistan Beyond Tremors and Terror: Critical Engagements with Political, Economic and Cultural Change

The Pakistan Conference Committee has organized an academic conference on Pakistan, titled Pakistan Beyond Tremors and Terror: Critical Engagements with Political, Economic and Cultural Change.

The goal of the conference is to move beyond the dominant narratives of Pakistan in the mainstream media and in recent academic (and policy) knowledge production, which has often reproduced crude and overly narrow analyses of the country and its people. It has been analyses which seems to be more committed to promoting United States foreign policy objectives than to stimulating any serious academic inquiry.

This conference will bring together scholars and students whose research moves beyond these prevailing views for a more complex understanding of Pakistan and its people. We seek to critically interrogate the "war on terror", religious violence and other topics scarcely covered in the mainstream.

The European Institutes for Advanced Study (EURIAS) Fellowship Programme is an international researcher mobility programme offering 10-month residencies in one of the 16 participating Institutes: Berlin, Bologna, Budapest, Cambridge, Delmenhorst, Edinburgh, Freiburg, Helsinki, Jerusalem, Lyon, Marseille, Paris, Uppsala, Vienna, Wassenaar, Zürich. The Institutes for Advanced Study support the focused, self-directed work of outstanding researchers. The fellows benefit from the finest intellectual and research conditions and from the stimulating environment of a multi-disciplinary and international community of first-rate scholars.

EURIAS Fellowships are mainly offered in the fields of the humanities and social sciences but may also be granted to scholars in life and exact sciences, provided that their proposed research project does not require laboratory facilities and that it interfaces with humanities and social sciences. The diversity of the 16 participating IAS offers a wide range of possible research contexts in Europe for worldwide scholars. Applicants may select up to three IAS outside their country of nationality or residence as possible host institutions.

The Programme welcomes applications worldwide from promising young scholars as well as from leading senior researchers. The EURIAS selection process has proven to be highly competitive. To match the Programme standards, applicants have to submit a solid and innovative research proposal, to demonstrate the ability to forge beyond disciplinary specialisation, to show an international commitment as well as quality publications in high-impact venues.

For the 2015–2016 academic year EURIAS offers 44 fellowships (22 junior and 22 senior positions).

All IAS have agreed on common standards, including the provision of a living allowance (in the range of € 26,000 for a junior fellow and € 38,000 for a senior fellow), accommodation (or a mobility allowance), a research budget, plus coverage of travel expenses.

# <u>Centre for Migration and Refugee Studies:</u> Summer Short Courses

#### June 1-26, 2014

The Center for Migration and Refugee Studies (CMRS) at The American University in Cairo (AUC) is offering the following four short courses during the month of June 2014:

- International Refugee Law (June 1 5, 2014)
- Protection Challenges among Vulnerable Migrants and Refugees in Transition Times: Egypt as a Case Study (June 8 - 12,2014)
- Addressing Global Trends: Psychosocial and Mental Health Interventions for Refugees Living the Urban Context (June 15 – 19, 2014)
- Immigration Detention: Challenges of a Growing Trend (June 22 -26, 2014)

The courses are offered for graduate level students, researchers and practitioners in the field of migration and refugees. The maximum number of participants in each course is between 10 - 30. All courses are conducted in English and no translation facilities are provided. Participants should have a sufficient command of the English language.

Interested applicants can apply for one course or for all the four courses. The fee for each course is \$ 500. Tuition waiver options are offered only to qualified candidates from the developing countries. However, participants who get tuition waiver are responsible for the cost of their flight to and accommodation in Egypt.

NB: Non- Egyptian applicants are strongly encouraged to apply three weeks before the course start, in order to have enough time to obtain their visa. All courses will take place in the Tahrir Campus in Downtown Cairo. The exact location and room numbers will be forwarded to accepted participants before the start of the courses.

- For participants who are self-sponsored, sponsored by other organization or their employers: 5th of May
- For Participants requesting tuition waiver: 12th of May
- Deadline for paying course deposit (30% of the total course's fee) is 12th of May
