Michael Fenn has been an Ontario Deputy Minister under three Premiers, municipal chief administrator in Hamilton/Burlington, founding CEO of both Toronto/Hamilton regional transportation authority Metrolinx and regional health authority Mississauga Halton LHIN. Faculty of Environmental Studies Study Abroad Program

Starting Summer 2017, the Faculty of Environmental Studies will be offering a <u>Semester Abroad</u> program of field courses, using its new EcoCampus in Costa Rica and other locations in the region. The program emphasizes experiential education, building on our long-standing relationships with diverse communities in southern Costa Rica, including women's organizations, agricultural producers and cooperatives, environmental protection and social justice groups and Indigenous communities.

Courses will usually take a community-based approach, developing collaborative projects that provide learning opportunities. Six Courses will be offered through May and June 2017 on: Environmental Arts and Food Sovereignty; Conservation and Development for Sustainability and Well-Being; Globalization and Indigenous Peoples; Natural History: Political Ecology Encounters and Environmental Education; Environment and Health: Ecosystem Approaches in the Field; and Protected Area Management. These courses are open to all 3rd/4th year and all graduate students at York University. The final deadline for registration is March 1, 2017.
