



#### [Our First Book: THE COMEBACK: How Aboriginals are Reclaiming Power and Influence - by John Ralston Saul](#)

For the last hundred years, Aboriginal Peoples have been making a comeback – a remarkable comeback from a terrifyingly low point of population, of legal respect, of civilizational stability. A comeback to a position of power, influence, and civilizational creativity. ## 2017 Frontier College National Forum – Literacy and Poverty

Frontier College's national forum will examine the role of literacy in poverty reduction strategies across Canada. The panel will consider the challenges faced by individuals, employers, and communities, and explore the role of literacy in alleviating poverty. The forum will be webcast live to satellite conferences in Whitehorse, Vancouver, Edmonton, Saskatoon, Toronto, London, Montreal, and Halifax. The satellite conference will be held at OISE (U of T), and registration and networking will begin at

11:30am. Opening remarks will begin at 12:00pm, with **keynote speaker Kaydeen Bankasingh**. She is a local, grassroots community leader living, working and raising a family in the Lawrence Heights, Neptune community. For the past 9 years she has worked extensively with residents to develop community capacity to influence local decision-making and civic processes. Currently she is working with local agencies and residents to establish equitable spaces and structures that strengthen collaborative community development work and collective impact.

Kaydeen believes that empowering a resident with the capacity to be an active participant in their own life can be the most important step in decreasing the impacts of poverty on quality of living.
