SPPA Professor Thomas Klassen's Co-Authored Book on Helping Students Succeed Translated into French



How to Succeed at University (and Get a Great Job!): Mastering the Critical Skills You Need for School, Work, and Life has been translated into French. Authored by York University public policy and administration Professor Thomas Klassen and humanities Professor Emeritus John Dwyer, the book demonstrates that the best preparation for success at life and on the job is succeeding at university.

More than 2,000 copies of the book's English version have sold in North America, while the free, <u>open access version</u> has been downloaded many thousands more times. The French version, **Décrocher son diplôme universitaire (et l'emploi de ses rêves!): Comment maîtriser les compétences essentielles menant au succès à l'école, au travail et dans la vie is available in open access (free PDF) form, in addition to paper and ebook versions. Published by the University of Ottawa Press and translated by Émilie Laramée, the book fills an important void for students studying in French, both in Canada and internationally. This book shows that teamwork, meeting deadlines, overcoming challenges, writing well and dealing with people are essential in any professional job. These same skills are also vital to becoming a strong student. "The French edition will allow a new crop of readers – those beginning their university studies straight from high school, mature students returning to school and others – to get the most out of learning and flourish in work and life after their degree," Klassen says.**

<u>SPPA is Hiring:</u> Full Time Tenure Stream Professorial Position in Justice Administration (Open Rank) at York University (Markham Campus)



The School of Public Policy and Administration, Faculty of Liberal Arts & Professional Studies invites applications for a tenure-track professorial-stream appointment in Justice Administration at the Assistant, Associate or Full Professor level, to commence July 1, 2019. The position will be based at the York University Markham Centre Campus when the new campus is operational (expected in Fall

2021). Between July 1, 2019 and the opening of the Markham campus, the appointee will assume a combination of teaching responsibilities at York's Keele campus and leadership responsibilities including the curricular development and delivery of a new Bachelor's program in Justice Administration for the Markham campus. A PhD in law, public administration or related discipline with a specific focus on Canadian justice administration or PhD equivalent, typically an SJD or LLM/MPA/MA with a substantial record of relevant professional experience is required. Candidates must demonstrate excellence or promise of excellence in teaching and in scholarly research, and to have produced publications appropriate to their stage of career. Applicants should have an ongoing program of research and specialize in Canadian or Ontario justice system management and reform, including criminal, family and civil justice systems. Ontariobased professional experience in justice administration is preferred. In addition to having an up-to-date and in-depth knowledge of the Canadian/Ontario justice systems, the candidate will have the ability to enhance the reputation of the School of Public Policy and Administration and develop new experiential education partnerships for student learning, professional development and research. The successful candidate must be suitable for prompt appointment to the Faculty of Graduate Studies. The position may involve graduate teaching and supervision in the Master of Public Policy, Administration and Law program and the Graduate Diploma in Justice System Administration, as well as undergraduate teaching. Demonstrated pedagogical innovation in high priority areas such as experiential education and technology enhanced learning is preferred, as is a track-record of service in academic, professional and community settings.
