My name is Matthew Ko. I'm a first year student studying Public Administration (BPA) at York University. I came to study high school here in Toronto from Hong Kong in 2016.

Stepping into my last year of high school (2018-2019), I started going through all the programs that Ontario universities offered. It wasn't until the Ontario Universities Fair in October 2018 that I found out about the BPA program. It was in the corner where York University's booth was located and a representative introduced the Public Administration program to me, which caught my attention. Later in my last year of high school, I found myself interested in government policy making and its effect domestically and internationally. Issues like climate change, public transit, housing, surveillance, and police militarization caught my attention through the two courses I was taking in grade twelve: Engaging the Origins of Western Thought and History and Law, and World Issues. There was also another "push factor" for my decision in choosing the BPA program, which is the on-going pro-democratic movements in Hong Kong. As a Hong Kong Canadian, even though I decided that I want to build a life here in Canada, I still care about the political and social environment of the city where I was born and raised, hoping that one day there will be a truly democratic election in Hong Kong. This led me to be more eager in learning about democracy and western liberal bureaucracy.

Fast forward to the first semester here in the BPA program. I met my classmates and friends, the amazing professors, and executives in the Public Policy and Administration Student Association (PPASA). They created a welcoming environment that made York a home away from home. The professors and PPASA executives gave us their insight and their do's and don'ts at university. Their advice was invaluable and they are always there when you need help. In the courses I'm taking, I learned to appreciate the work of civil servants that work behind the scenes, admiring their impartiality and work ethic. This inspires me to live up to the standard they set.

I remember on the first day of university, there was a speech by the College Head, Professor Simeon. He highlighted that one of the keys to success in university is to be involved. Even though I'm an introvert, I tried my best to be active and participate in events like intramural Broomball, weekly practices with the York Dragon Boat Club, the McLaughlin College

Community Choir, go to Tatham Hall Residence Council meetings, and became a Junior Ambassador of PPASA. Becoming a Junior Ambassador is one of the best decisions I have made. The year 2019 marked the 100<sup>th</sup> anniversary of the International Labour Organization (ILO). Established in the wake of the "Great War" (WWI), the founding mission of the ILO was based on the premise that "social justice is essential to universal and lasting peace." However, this goal has been far from realized in the last century.
