The <u>Alumni Recognition Award</u> acknowledges exceptional contributions made by one alumnus/alumna to the activities and programs of the School, as well as to the mentoring of its students and new professionals.

The Foster – Greene Award for Excellence in Public Policy, Administration and Law recognizes an alumnus/alumna of the MPPAL program whose work has demonstrably and significantly advanced social justice, human rights, ethics and good governance in congruence with the MPPAL program's founding principles. The Award recipient will normally have min. 10 years of work experience in the broader public/NGO sector.

The **Emerging Leader Award** recognizes a current student or recent alumnus/alumna of the School who is an emerging leader within the broader public sector (including the non-profit sector) and represents the ideals, values and abilities of sound, responsible and engaging public policy and administration in congruence with the School's vision to promote Good Governance. The **Practicum Honouree Award** recognizes individuals who have made exceptional efforts to provide practicum opportunities for the School's fourth-year students.

Writing Centre Director's Message - Writing Centre Procedures During the Coronavirus Outbreak

As you will have heard by now, the University is switching to online-only instruction starting Monday, March 16. This means that the Writing Centre must also go 100% online, and we have been preparing for just this eventuality. Unfortunately, however, that means that the actual physical space of the Writing Centre, on 3rd Floor Ross, will no longer be assisting students directly. We have also been forced to cancel all remaining "in-person" or group activities in the Writing Centre for the remainder of the Winter term. This includes in person one-to-one meetings, all drop-ins (in S311 Ross and in the Library), all workshops and seminars, and any further meetings of the Multilingual Writing Studio.

Members of the Dr. Keith O'Regan-led Thesis Café will be contacted by Dr. O'Regan to arrange further meetings via videoconferencing. The ESL Open Learning Centre will also be in contact with their students about possible online group activities.

However, we are still open and helping students to the extent possible. If you visit <u>our website (https://writing-centre.writ.laps.yorku.ca/)</u> you'll see that our instructors have shifted online to provide both <u>real-time (synchronous) one-to-ones</u> <u>via video chat</u>, and "<u>asynchronous etutoring</u>" – where you upload your paper to our website, and an instructor will reply with feedback within 24 hours.

If you'd like to book an appointment, please visit <u>the Writing Centre schedule</u>, and look for your favourite instructor. The Instructors available for online one-to-one appointments will be marked "Online Only." Instructors available for asynchronous etutoring will be labelled "Etutor Only". Please note: you must have a working camera attached to your computer in order to properly participate in online synchronous sessions. Instructors will not be able to call you at home or consult with you over the phone. The other normal conventions of the Writing Centre still apply you may book one appointment a week in normal circumstances. If you have been meeting with a Learning Disability Specialist, please call the Writing Centre and ask to speak to James Robertson (416-736-2100 x22036). An online one-to-on Video chat will be scheduled for you.

Strategy Advisor Development (7 positions plus 3 positions) - Ontario Ministry of Labour, Training, and Skills Development

The Labour Ministry is hiring for a total of 10 temporary positions across three branches. In these roles you will lead and conduct evidence-based policy research, analysis and synthesis to formulate recommendations, strategies and policy options for senior management; design complex evaluative initiatives and studies to support policy and program recommendations on current and emerging issues affecting health and safety prevention; and provide technical leadership and coordination in the development of program, policy options, directives and implementation plans.

Plastics Campaigner - Oceana

Oceana are seeking a Plastics Campaigner who will support their work to reduce single-use plastics in Canada. The incumbent is preferably bilingual in French and English and will work in Oceana's Ottawa or Toronto office, with Ottawa being the ideal location. The Campaigner will work with a multidisciplinary team to develop and execute Oceana Canada's campaign to end single-use plastics by calling for plastic-free policies, public spaces and consumer choices. This position requires strong persuasion, communications, problem-solving, project management and grassroots campaigning skills. The ideal candidate is ction- and detail-oriented, with experience working collaboratively to advance policy. The Campaigner will report to the Campaign Director, based in Ottawa.

Regulatory Affairs Consultant - Toronto Hydro

The Regulatory Affairs Consultant (Government Relations) will be responsible for leading detailed policy research, engaging with internal and external stakeholders, providing advice to senior leaders and to advance the organization's policy and government relations interests. The successful candidate will join a team of policy and government relations professionals responsible for managing relationships at the municipal, provincial and federal level.

First Nations, Inuit and Metis Lead - Canadian Partnership Against Cancer

The lead will be responsible for embedding the First Nations, Inuit and Métis priorities across the work of the relevant portfolio of initiatives, related to CPAC's 2022 outcomes and new work in the refreshed strategy. A key focus for the First Nations, Inuit and Métis Lead will be planning and scoping work related to the suspicion to diagnosis project that is at the onset of planning, in addition to synoptic surgery/pathology and survivorship initiatives. The First Nations, Inuit and Métis Lead will collaborate with multiple stakeholders, including internal staff, external advisory groups, patient and family representatives and First Nations, Inuit and Métis partners to effectively contribute to the success of the work.

Research Assistant - Indspire

Indspire is currently seeking two (2) Indigenous students or Indigenous recent graduates to join their Research Knowledge Nest's as Research Assistants. This 12-month paid contract (May 2020-April 2021) will give you the opportunity to develop your research and analytical skills in a supportive, employee-centered environment. In these roles, Indigenous students and Indigenous recent graduates have an opportunity to take on research in an environment curated to develop research skills, build a professional network and experience different applications of research in the workforce. The successful candidates will be mentored by Indigenous and non-Indigenous researchers, produce original research and reporting, support knowledge mobilization and learn from various experts. At the end of the contract, it is expected that the individuals will successfully apply for graduate school and/or applied research roles.

McIntruff Fellowship in Gender Budgeting - Canadian Centre for Policy Alternatives

Under the supervision of a Senior Researcher, the Fellowship holder will participate in the development of a Gender Budget Portal and produce related public policy materials for publication. This is a full time summer position (May-August) based in Ottawa.
