SPPA welcomes Dr. Ian Stedman as new full-time faculty member in the area of Canadian public law and governance

Dr. Stedman's research program is focused on the law of public sector governance and accountability, and on the regulation of innovative and emerging technologies. He is an expert in Canadian parliamentary ethics law, but has also written about the governance of artificial intelligence and the use of new technologies in healthcare. Dr. Stedman's work in healthcare has led to a Fellowship in A.I. Law & Ethics at SickKids and to a post-doctoral position at Dr. Rebecca Pillai Riddell's O.U.C.H. Lab at York.

Dr. Stedman recently received his PhD from Osgoode Hall Law School and has several years of professional experience and appointments outside York University. As an inquiries officer for the Ontario Integrity Commissioner, he advised MPPs and their staff on legal and ethical obligations under ethics and transparency legislation for three years. Since called to the bar in 2009, he has practiced law for three years, more recently as an investigations lawyer with the Royal College of Dental Surgeons of Ontario. Since 2019 he has served on the Panel of Experts for the European Union's Rare 2030 Project and is a Member of Data & Registries subgroup.

While Prof. Soennecken will continue to teach in the MPPAL program and be available to supervise and mentor graduate students, administrative leadership positions collegially rotate among faculty members every few years so that professors can once again devote more time to their research projects.

#### **Announcements**

Prof. Soennecken has three major projects on the go at the moment: First, together with Delphine Nakache (University of Ottawa, Canadian lead) and François Crépeau (McGill), she will be studying the vulnerability of migrants seeking protection in Europe, North America, the Middle East and Africa as part of an international consortium of researchers headed by the Max Planck Institute for Social Anthropology (Germany). To do so, the <u>@VULNERproject</u> team was recently awarded a <u>large</u>, <u>three-year research grant as part of the European Union's prestigious Horizon 20/20 funding scheme</u>, matched by a <u>grant</u> from the Social Science Research Council of Canada (SSHRC) and the Fonds de recherche du Québec – Société et culture (FRQSC).

The <u>VULNER</u> project is driven by a central idea. Although the concept of "vulnerability" is increasingly used as a tool by policymakers around the Globe to identify migrants in special need of protection, there is no one definition of the concept used, nor are the practical and legal implications of identifying a migrant as vulnerable clear. Given that every migrant is vulnerable to some extent (depending on the context, their resources, and intersecting social identities, such as ethnicity, gender, age, and nationality), policy choices that privilege some vulnerabilities over others risks exacerbating existing vulnerabilities further or even producing new ones. The research aims to provide scientific data and analysis to support evidence-based policymaking in the European Union and beyond.

#### **Announcements**

Prof. Soennecken's second research project, the Local Engagement Refugee Research Network (LERRN), is aimed at enhancing the understanding of the role of civil society in the global refugee regime. Civil society actors play a significant role in developing innovative responses to a wide range of refugee situations, yet they are often not recognized as actors with critical insights by policy makers. The @LERRNing project, which commenced in 2018 and runs until 2025 is funded by a <u>SSHRC partnership grant</u> and is lead by James Milner (Carleton). The Canadian partners, including three other colleagues at York, are carrying out research in collaboration with local academics, refugees and NGOs in Kenya, Tanzania, Lebanon and Jordan. The overall aim of the project is it to identify how civil society can contribute to improved outcomes for refugees through better policy making.

Her third major project involves leading one of the oldest scholarly (bi-lingual, peer-reviewed) journals on forced migration, <u>Refuge: Canada's Journal on Refugees</u> (founded in 1981 and published by the <u>Centre for Refugee Studies</u> at York), through its digital transformation as its editor-in-chief while running the day-to-day operations of the journal. <u>Refuge</u> has been fully open access since 2013 and has a global readership ranging from academics to policy makers and practitioners. Its publication is supported by SSHRC. Digital publishing poses a host of new challenges and opportunities, ranging from dealing with technical limitations to ensuring proper archiving, optimizing digital indexing and broadening the distribution of published research. Prof. Soennecken is tackling these challenges together with her managing editor, Kathryn Barber (Sociology, York) and two other editorial team members, Christopher Anderson (Laurier) and Pierre-André Thériault (Osgoode, York).

While Prof. Soennecken was initially scheduled to be on sabbatical at the <u>Centre for Global Studies</u> (University of Victoria, B.C.) and the <u>Centre for Comparative Immigration Studies</u> (UC San Diego) in 2020-21, due to COVID-19, she will instead be working on these projects from her home in Toronto for now while remotely teaching two seminars along her lines of interest - one on law, citizenship and migration and the other on politics, law and the courts.

#### **Manager, Intergovernmental Relations - TTC**
