MENTORSHIP CIRCLES – CALL FOR PARTICIPATION

Dear alumni and students,
We are pleased to announce the launch of a new round of mentorship circles at SPPA.

Circles have 3 members (3 of the 4 categories represented in each circle):

Level 1: 1 Upper year BPA/MPPAL student or recent graduate at entry level position

Level 2: 1 Analyst/Advisor

Level 3: 1 Manager

Level 4: 1 Sr. Executive E.g.: Director, ADM, DM

Each group will consist of a Level 1, 2 and 3 or a Level 2, 3 and 4.

The minimum commitment is to hold two meetings for each mentorship circle by the end of March 2021, and preferably one more by the end of April or May, with the aim to advance the professional development and careers of participating members. Three or more meetings are recommended based on feedback from the 2017-18 mentorship circle participants (50% of participants recommend 3 meetings, 50% recommend more than 3 meetings). 93% of the 2017-18 program participants indicated that they would take part again (7% were unsure, 0 negative responses). All meetings will be held virtually during this cycle.
